Intellectual Property Rights (IPR) Cell Policy

Objective:

The Intellectual Property Rights (IPR) Cell at PES's Modern College of Arts, Science and Commerce, Warje, Pune aims to foster a culture of innovation and creativity within the academic community. The primary objective is to educate, support, and manage the intellectual property generated by students, faculty, and researchers. The IPR Cell seeks to enhance the institution's reputation, encourage research, and facilitate commercialization by safeguarding intellectual creations through patents, copyrights, trademarks, and designs.

With this objective college is establishing an IPR cell by April 2024.

Functioning:

- 1. Awareness and Education: The IPR Cell will conduct regular workshops, seminars, and training sessions to educate stakeholders about various forms of intellectual property, the importance of IP protection, and the process of obtaining IP rights.
- 2. **IP** Advisory Services: The Cell will guide intellectual property identification, protection, and commercialization. This includes assisting with patent searches, IP registration, and legal consultations.
- 3. **IP** Management: The IPR Cell will oversee the process of IP filing and management, ensuring that all applications are handled efficiently. It will maintain a repository of all intellectual property developed within the college and track its status.
- 4. **Commercialization Support:** The Cell will work to create partnerships with industry and investors to facilitate the commercialization of college-generated IP. It will help negotiate licensing agreements and manage IP-related contracts.

Course of Action:

1. **IP Disclosure:** Faculty and students must disclose any new inventions, creative works, or research outcomes to the IPR Cell for evaluation and protection.

- 2. **IP Evaluation:** The Cell will assess the potential and patentability of disclosed IP and recommend appropriate protection strategies.
- 3. Application Process: Once protection strategies are determined, the Cell will manage the IP application process, including documentation and submission.
- 4. Monitoring and Enforcement: The Cell will monitor the use of the institution's IP and enforce rights against unauthorized use.

Quarterly Meetings:

The IPR Cell will convene quarterly meetings to review progress, discuss ongoing IP matters, and strategize future actions. These meetings will include:

- 1. Review of IP Portfolio: Assess the status of current IP filings and management.
- 2. Update on Commercialization Efforts: Discuss progress and challenges in commercializing IP.
- 3. Training and Outreach Plans: Plan and evaluate educational programs and workshops.
- 4. **Strategy Formulation:** Develop strategies for improving IP management and protection practices.
